TRANSFER INSTRUCTIONS

If you are an F-1 Student transferring to the American Language Institute (ALI), San Diego State University from another institution in the United States, you will need to present the following documents to the ALI Admissions Office no later than your ALI program start date.

1. A completed *F-1 Student Transfer Form*.
2. A photocopy of the I-20 Form(s) from all schools you have previously attended in the United States and photocopies of your passport, visa, I-94, and EAD card (if applicable).

You must first notify your current school of your decision to transfer. Please note that we cannot issue an I-20 Form before your current school “releases” your Student and Exchange Visitor Information System (SEVIS) student record to the American Language Institute, San Diego State University.

Please note that receipt of your F-1 Student Transfer Form does not complete your transfer procedure. In order for the American Language Institute, San Diego State University to complete your transfer procedure and issue a Form I-20 you must register, pay your tuition, and carry a full course of study.

As an F-1 student, it is your responsibility to complete your transfer procedure with the ALI Admissions Office within 7 of the program start date noted on your I-20. If you fail to receive a “transfer completed I-20” by the 8th day, you may lose your F-1 visa status and jeopardize your legal stay in the U.S. Please contact the ALI Office if you cannot begin your program on the date listed on your ALI application.

If you plan on traveling outside of the U.S. prior to your program start date please contact us immediately. You will need a “transfer pending I-20 Form” from the ALI to reenter the U.S.
