



American Language Institute

Admission to most ALI programs is open to all persons 18 years old and over who have completed high school. ELST youth programs accept younger students.

The U.S. government requires persons who come to the U.S. for full-time studies (18 hours per week or more) to obtain F-1 student visas. To apply for an F-1 student visa at the U.S. embassy or consulate in the student's country of origin, an I-20 form will be needed. An I-20 form is a government approved document issued by the ALI. To receive an I-20 form, students must first complete the ALI Application Form and provide a financial statement.

Please allow a minimum of one-two (1-2) weeks to process your application.

Application Checklist:

Step One

New Applicants for all ALI programs must send the following items.

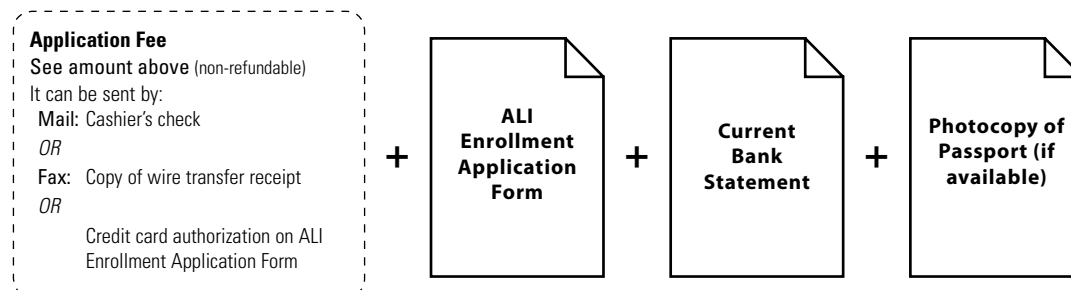
1. Application fee (non-refundable): \$175.
2. ALI Enrollment Application Form.
3. Current Bank Statement with existing funds in the account
 - Affidavit of Financial Support (if bank statement is not in student's name).
4. Photocopy of passport (if available).

Applicants transferring from another school in the U.S. to the ALI must also include the following items.

5. ALI Transfer Eligibility Form (available at www.americanlanguage.org).
6. Photocopies of your current I-20, passport, visa and I-94 card.

I-20 Application for a U.S. Visa

If the primary purpose for entering the U.S. is study, we recommend an F-1 student visa because:

- an immigration officer may deny entry at the U.S. border to any person who does not have an F-1 student visa if the main reason for coming to the U.S. is to study,
- persons entering the U.S. on a temporary tourist permit (Visa Waiver) may stay in the U.S. for only 90 days and may not change their status or extend their stay, and
- it may be difficult to change your status from tourist to student after arriving in the U.S.

To receive an I-20, you must complete this form and provide a financial statement from you or your sponsor, certifying that you have enough funds for tuition and living expenses while you are in the U.S. The amount of funds you need will depend on the cost of the program you want to take plus approximately \$1,000 per month for living expenses must be available. In addition, if you are bringing dependents, you should estimate an additional \$500 per month for a spouse and \$250 per month for a child.
